Cancellation Policy - NO REFUNDS - COMPLETELY TRANSFERABLE

Non - Refundable Cancellation Policy: All guest rooms or event area reservations will be handled in accordance with our stated Four (4) Day Reservation Credit Vouchers Policy. The Cochrane House Luxury Historic Inn requires full payment for reservations booked at our establishment. Payments are non-cancellable and non-refundable. We will charge the full amount of the reservation to the credit card the guest provided at time of booking. Guest is required to notify us by email within 24 hours of initial booking if there are any potential changes to their reservation, because we DO NOT offer a cancellation or refund policy. All guests are given a four (4) day reservation credit voucher in the event of a cancellation to reserve a future date. Four (4) day reservation credit vouchers are non-transferable; any changes MUST be paid in full and subject to the reservation modification fee.

Group Cancellation Policy: A separate cancellation policy applies for all call-in group cancellations. For group / whole house rentals we require a non-refundable deposit and we require a minimum 2-night stay (owner discretion). Please contact us by email to inquire: info@thecochranehouse.com

Reservation Reschedule Notification: We understand that sometimes it is necessary to change a reservation. All reservation changes must be by EMAIL ONLY. We do not accept reservation changes by phone.
